41st Annual Ozark Quilt Fair

- When:** Saturday, September 14, 2019, 10:00 a.m.–2:00 p.m. There is no rain date. If weather is questionable, call 479-799-4274 to find out if the fair will take place.
- Cost:** \$10 for exhibitors; free to the viewing public.
- Rules:** **All quilts must be quilted or tied by hand or by free-motion machine quilting. No computer-programmed, template, or pantagraph patterns.** Tops may be pieced, embroidered, or appliquéd (machine piecing is acceptable). No other forms of needlework are to be exhibited or sold (e.g., no crochet, cross-stitch, knitting, etc.).
- Antique as well as new quilts are welcome. Quilts displayed may be for sale. All quilts should include a label indicating prices, if the quilt is for sale, and history of the quilt (creator, residence, date, pattern, etc.). **If you are selling quilts, please read over the enclosed Arkansas sales tax information sheet.**
- Registration forms and fee must be turned in to the museum **by 5:00 p.m., Wednesday, September 11.**
- Exhibits:** Ropes will be stretched between trees for hanging quilts. Each exhibitor may plan to use up to 15 feet of the ropes, unless space and number of quilters in attendance allow more or less. Feel free to bring lawn chairs and card tables if you need extra display space.
- Security:** Shiloh Museum staff and volunteers will be at the event all day, but YOU are the best security for your quilts.
- Food:** Each entrant will receive a free sack lunch (sandwich, chips, drink). Additional lunches may be pre-ordered for \$5 each.
- Awards:** Viewer's Choice awards will be given in both new and antique quilt categories. First prize in each category is \$50, second prize, \$35, third prize, \$15. Awards will be presented at 2:00 p.m.

The Arkansas Department of Finance and Administration requires that state sales tax be collected on any sales at the Ozark Quilt Fair.

1. Entrants who are displaying but not selling their quilts will not be affected in any way.
2. Entrants who wish to show AND sell their quilts must follow these State requirements:
 - a. Entrants who sell quilts **MUST** collect sales tax on their sales (information the museum obtains from the State will explain what tax amounts to collect) and then turn into the museum at the end of the quilt fair their tax-reporting forms AND the collected sales tax, which the museum, in turn, submits to the State.
 - b. If you are a quilt “vendor” who already has a sales-tax permit, you’re allowed to send in your own taxes, rather than doing the reporting through the museum. If this is the case, however, the State asks that you write your sales-tax permit information on the tax-reporting form (that the museum will give you at the Quilt Fair) and submit that form to the museum so that we can return it to the State with our other forms.
 - c. There appears to be nothing in the regulations that prohibits the distribution of a “business card” or simply your contact information, so quilters who would like to contact or be contacted by a quilt fair visitor to enact a sale outside the quilt fair should be able to do that.
